





## TERMS & CONDITIONS

1. The envelope containing tender and other documents should be neatly written the name of the work, reference no., closing date failing which the tender will be rejected and returned without opening.
2. The contractor should mention the correct postal address and contact number in the space provided in the agreement. If there is any change in the postal address/ contact number, the contractor should inform to the office in writing immediately about the change. Institute shall not be responsible for non-receipt of document due to postal delay/ undelivery/ non-recipient at contractor's end.
3. The firm should have at least 5 (five) years experience of construction of similar works. The contractor should have prior experience of being worked in ICAR-IISR, Lucknow or enlisted/registered in CPWD/other Govt.Deptt.to similar works.
4. The contractor may quote the rate after inspection of site and clarification of all details of the tender document from the Indenter / Incharge- Estate Section of this Institute.
5. Incomplete or conditional quotations accompanying with/ without EMD shall be rejected.
6. The filled in tender should accompany a covering letter in their letter pad along with Enlistment Certificate for and Experience Certificate, PAN/GST card.
7. Work shall be carried out as per the CPWD specification instruction, direction and satisfaction of Incharge-Estate Section of this institute.
8. The contractor shall arrange / hire the generator, welding machine, drill machine and other tools and tackles required for the work.
9. The EMD of Rs.3000.00 may be drawn in favour of the ICAR unit, IISR, Lucknow and the EMD of the successful tenders shall be retained with the office and shall be released after the work is over satisfactorily.
10. The rate shall include all charges such as labour, materials, transportation, tools and tackles, taxes, freight, octroi and other incidental charges if any. No charges shall be paid extra other then the quoted rate.
11. The work should be started within 10 (Ten days) form the date of issue of the work order failing which the work order shall be cancelled and EMD forfeited on the recommendation of the Incharge-Estate Section / Indenter of this Institute.
12. No part payment will be made and the final payment shall be released on satisfactorily completion of the work against bill submitted in duplicate by the contractor.
13. The work should be completed within 45 days from the date of receipt of work order failing which the work order will be cancelled and EMD forfeited.
14. In case the contractor fails to complete the work within the stipulated / extended period of time, penalty shall be imposed to the contractors @ 0.25% per week, maximum of 2.5% of the total cost of the work.
15. During execution, the Incharge- Estate Section may add one or more items to the awarded work due to some technical difficulties or minor modification.
16. The inferior quality of rejected material are to be removed immediately from the site failing which the same will get removed by the institute and the expense involved will be deducted from the contractor's bill.
17. The water and electricity will be provided to contractor for which 2% will be deducted / settled bill.
18. In case of dis-satisfactorily work the contract may be terminated at any time and in such case the EMD / Security Deposit shall be forfeited.
19. In case the contractor fails to complete the work within the such stipulated / extended period of time and according to our satisfaction, the Director, ICAR-IISR, Lucknow shall have the right to terminate the contract and get the work done through any other firm or agency. In such case the EMD and the security deposit of the contractor shall be forfeited.
20. Quantity of work may be increased or decreased according to the actual need of work and hence, minor deviation of work shall be under taken as per quoted rate.
21. The contractor has to deposit 10% of the total estimated cost through bank guarantee for the period of contract towards proper performance of the contract after issue of work order and the same shall be released after six months of successful completion of work and will be treated as guarantee for successful performance of completed work.
22. After completions of the work within six months, if any defect or damage or poor workmanship is noticed, the same shall be rectified by the contractor, within ten days failing which the security deposit shall be forfeited.
23. After completion of work, the left over material at the site, if any, shall be removed within seven days failing which action will be initiated.
24. The Director, ICAR-IISR, Lucknow reserves the right to accept or reject any or all the tenders without assigning any reason there of and the decision of the Director, ICAR-IISR, Lucknow shall be final and binding to all concerned parties.
25. The Director, ICAR-IISR, Lucknow also reserves the right to cancel the work, after award of work due to some administrative technical reason.
