ADDENDUM TO THE MEMORANDUM OF UNDERSTANDING **BETWEEN** THE INDIAN INSTITUTE OF SUGARCANE RESEARCH, LUCKNOW AND **DCM SHR!RAM LIMITED**

WHEREAS, on 19th August, 2017, The Indian Institute of Sugarcane Research, Lucknow and DCM Shriram Limited, with its Units, DCM Shriram Limited, Sugar Unit: Ajbapur, Distt. Lakhimpur Kheri, DCM Shriram Limited, Sugar Unit: Rupapaur, DCM Shriram Limited, Sugar Unit: Hariawan & DCM Shriram Limited, Sugar Unit: Loni, all in the District Hardoi Uttar Pradesh, entered into a Memorandum of Understanding to enhance the income of rural sugarcane farmers, improve their lives through higher yield and better quality of sugarcane production,(hereinafter referred to as MOU).

WHEREAS, this Memorandum of Understanding remains in full force and effect, and

WHEREAS, the said parties now have agreed to make an addendum to the MOU to extend the Scope and terms of the existing MOU and also to add CSR Activities.

NOW, THEREFORE, the parties agreed as follows:

1. For the purpose of mutual benefits of the Parties, Article 2 "Scope of the Agreement" and Article 4.1 "Assistance" is amended and which will read as follows:

Article 2 " Scope of the Agreement

- I.) Obligations for IISR
- (a) Assessment of present income
- (b) Mid-line assessment of the existing MOU will be done in 2020.
- (c) IISR will suggest best management practices to be implemented in those adopted villages (5 villages of each Unit's of DCM Shriram) on :
 - i. Planting technique
 - ii. Balance fertilization
 - iii Integrated pest management
 - iv Other practices as and when required not only for sugarcane but for other crops in the area.
 - v IISR will assist in evaluating the measurable impact of CSR Activities.
- (d) Final assessment will be done in 2024.

II) Article 4 " Assistance"

4.1 At IISR premises IISR shall provide research support to DCM Shriram Limited at its cost as ongoing basis for the **five years (till 31**st **July, 2024**). Institute will provide boarding and lodging facilities on the basis of availability to researchers/farmers during their field visits in their Guest house on payment basis.

2. For the purpose of mutual benefits of the parties, Article 9 "CSR Activities" is added to the existing MOU.

Article 9 " CSR Activities"

- 9.1 Preventive Health Care and Sanitation
- 9.2 Education & Skill Development
- 9.3 Environment Sustainability
- 9.4 Strengthening of Pancayati Raj institutional areas
- 3. All other provisions of the Memorandum of Understanding dtd 19.08.2017 shall remain in full force and effect till 31.07.2024.

This Addendum to MOU shall enter into force from the date of its signing and remain in force till 31st July, 2024.
